### 5. Presentation

Presentation shows that pupils have a pride in their work and produce a large quantity of work to a very high standard. Work is effectively organised and provides students with a detailed set of materials which supports effective revision.

#### Strong - Strong:

Presentation shows that students take some pride in their work. It is produced to a good standard. There is an appropriate quantity of work which reflects the time allocated to the subject and supports revision. There is evidence of organisation.

#### RI - Requires Improvement:

Presentation is mixed but is appropriate to tasks in 75% of the book. Some of the work supports revision but students will need to use supplementary materials e.g. revision guides.

#### Concern - Concern

There is little work recorded in books and therefore would not support revision. Presentation is poor and some work is not completed. There may evidence of graffiti/doodling.
